

Brunswick County Fishing Club Crab Crusher Slam Fishing Tournament

Quick Facts

- May 25th, 2024, 6:00am-3:00pm
- Registration Cost- \$75 per boat (fish with as many people as you wish in accordance with safety regulations.)
- TWT (optional): Heaviest single fish \$25 entry (Winner takes all)
- TWT (optional): High Roller \$50 (payouts: 1st-55%, 2nd-30%, 3rd-15%)
- 3 Fish aggregate weight. Red Drum (18"-27"), Black Drum (14"-25"), and Sheepshead (10"+)
Acceptable Submissions:
 - 1 Red Drum, 1 Black Drum, 1 Sheepshead
 - 2 Black Drum, 1 Red Drum
 - 2 Black Drum, 1 Sheepshead
 - 2 Sheepshead, 1 Red Drum
 - 2 Sheepshead, 1 Black Drum
- Artificial and live bait allowed.
- Launch at any public ramp in Brunswick County. Weigh in at BCFC Beside the wildlife ramp in Sunset Harbor.

Full Rules and Regulations

1. Participation and Eligibility- Participation is open to anyone 18 years of age or older. Minors are eligible to participate with a parent or guardian signature on the release form. A completed participant registration and entry fee must be received no later than published deadline. You will need to have a valid North Carolina Saltwater Fishing License to participate. Please read all rules and regulations and remember to sign and initial your Waiver and Release of Liability.

2. Registration and Captain's Meeting- Participants registration will be open online via our website at www.mybcfc.org until the captain's meeting at 7 pm Friday, May 24, 2024. In person registration will happen on Friday May 24, 2024, from 5pm-7pm and on Saturday, May 25, 2024 from 5:30am-6:00am at the Brunswick County Fishing Club located at 3911 Hickory View Drive Sunset Harbor, NC. The captains meeting will be live streamed on Facebook for those who cannot make the captains meeting in person. Attendance at the live or online captain's meeting is mandatory for each participant unless authorized by tournament director.

3. Safety- Safe boating must always be observed. Participants are required to comply with US Coast Guard regulations including the possession of US Coast Guard approved personal floatation device (PFD).

4. Sportsmanship- All participants are required to follow high standards of sportsmanship, courtesy, and conservation. Non-compliance with tournament rules and regulations are grounds for immediate disqualification and any prizes awarded must be returned.

5. Permitted Fishing Methods- All fish must be caught with a hook and line only. Artificial bait and live baits are allowed.

6. Permitted Fishing Locations- Participants can launch their boats 30 minutes prior to lines in. Participants can then fish any area they choose as long as they launch from a public ramp in Brunswick County. If participants have their boat on a private lift or in a marina they may launch from there as long as they pass by a public ramp and take a photograph with a time and GPS stamp enabled prior to lines in. Participants may not receive assistance including but not limited to following a non-participant boat, the placing of markers by a nonparticipant, or receiving electronic, voice, or data communication from non-participants. All fishing locations must be in waters accessible according to the law and US Coast Guard regulations.

7. Scoring- Target species will include Red Drum, Black Drum, and Sheepshead. Boats will be scored on the aggregate weight of 3 Fish. Red Drum (18"-27"), Black Drum (14"-25"), and Sheepshead (10" +). One 3 fish submission per boat. All entries must be of legal size according to current NC regulations or the boat will be disqualified.

Acceptable Submissions:

- 1 Red Drum, 1 Black Drum, 1 Sheepshead
- 2 Black Drum, 1 Red Drum
- 2 Black Drum, 1 Sheepshead
- 2 Sheepshead, 1 Red Drum
- 2 Sheepshead, 1 Black Drum

8. Check In- Check in will begin at 2:00 pm the Brunswick County Fishing Club located at 3911 Hickory View Drive Sunset Harbor, NC. All participants must check in no earlier than 2:00 pm and no later than 3:00 pm.

9. Post Check in Party- Starting at 3:00 pm there will be the post tournament party including beverages and tournament winner's prize ceremony and sponsor recognition.

10. Protest- All protests must be in writing and delivered to a tournament official within 30 minutes of check in. The tournament director has the final say in all decisions. All protests must be accompanied by a \$100 deposit made out to the Brunswick County Fishing Club.

11. Rule Changes- Rules interpretation will be presented to the tournament director. The decisions of the tournament director are final and are not subject to appeal.

12. Release of Liability- A waiver and release of liability form is part of the registration pack, and every Captain is required to read, initial, sign, and date the waiver and release of liability form or they will not be eligible to participate.

13. Prize Structure- Cash prizes will be awarded to the top 3 based on 50 boats. For every 20 boats after we reach 50, we will add another place. If any recipient wins over \$600 dollars, they will be required to fill out required tax documentation before receiving prize money.
